## **Cannabis Control Appeals Panel Publishes Proposed Regulations**

SACRAMENTO – California's Cannabis Control Appeals Panel today announced the publication of proposed regulations in the California Regulatory Notice Register. This publication is the start of the formal rulemaking process and marks the opening of the 45-day written public comment period.
